## Town of Midland Overview

The Town of Midland is a lower-tier municipality in Central Ontario, Canada located on Georgian Bay in Simcoe County.

A safe, clean and hospitable community, Midland has a population of over 18,000. It is the economic hub of Southern Georgian Bay, which boasts a population exceeding 48,000 within a 25 km radius. In summer months, the area population grows to over 100,000 as seasonal residents flock to their cottages, and visitors stay at local hotels and the provincial and national parks.

Since time immemorial the area which is now the Town of Midland has been the homeland of the Huron-Wendat Nation and of the Anishinaabek people, who are now referred to in English as the Chippewa Tri-Council and comprised of Beausoleil First Nation, Rama First Nation, and the Georgina Island First Nation.

Located at the southern end of Georgian Bay's 30,000 Islands, our culturally rich Town has become the nerve center of North Simcoe for economic prosperity, fabulous lifestyle in idyllic surroundings and an abundance of recreational pursuits.

Midland is less than 2 hours from Toronto and just 40 minutes from Barrie or Orillia by vehicle. The Town is located on Highway 93 (Penetanguishene Road) which is accessible by Highway 400 or Highway 12. Midland is also accessible by water (Midland Harbour) or air (Midland/Huronian Airport).

Midland has a dynamic recreational waterfront, which includes the picturesque Harbour, and waterfront trail for walking, biking and rollerblading. The summer season affords an opportunity to view the beautiful horticultural displays throughout Midland. Take a stroll through the hub of our downtown area and enjoy the array of boutiques, restaurants and services, as well as the beautiful murals scattered throughout the downtown core. The Town is the home of Ontario's Best Butter Tart Festival and offers many other amenities, festivals, and community events.

As well, there are multiple healthcare services and a local hospital available to the surrounding community.

The Town has many exciting initiatives and forward-thinking projects in progress and upcoming significant infrastructure and development projects are currently in the planning and design phases.

### Position Summary:

The Director of Finance/Treasurer plays a pivotal role in the Town of Midland's executive leadership team, reporting directly to the Chief Administrative Officer (CAO). As a key member of senior management, the Director of Finance/Treasurer provides strategic direction and oversight for all financial functions, ensuring the long-term fiscal sustainability, accountability, and transparency of the Town's operations. This position leads the Finance Department, encompassing accounting, budgeting, procurement, and financial reporting, and fulfills the statutory obligations of the Treasurer under the Municipal Act, 2001. The Director of Finance/Treasurer also serves as a trusted advisor to Council, the CAO, and other departments on financial matters, shaping financial policy and fostering a culture of excellence and continuous improvement across the organization.

This position is an excellent opportunity for a seasoned finance professional to make a significant impact in a growing municipality. The role requires a leader who can provide strategic financial guidance, mentor a high-performing team, and work collaboratively across departments to support corporate initiatives. Occasional evening work is required to attend Council and committee meetings.

The salary range for this role is \$143,684.90 - \$174,649.89. This advertisement is to fill an existing vacancy.


### Key Responsibilities:

- Oversee all financial operations including accounting, budgeting, taxation, procurement, and financial reporting, ensuring compliance with the Municipal Act, Public Sector Accounting Standards (PSAS), and other relevant legislation.
- Provide expert financial advice and reports to Council, CAO, and department heads, supporting strategic decision-making.
- Lead the development and implementation of financial policies, procedures, and internal controls that promote accountability, innovation, and efficiency.
- Manage procurement processes, ensuring adherence to municipal bylaws and best practices.
- Coordinate the preparation of the annual Financial Information Return (FIR) and act as liaison with external auditors.
- Develop and implement long-term financial strategies aligned with Council's strategic priorities, including forecasting, risk analysis, and asset management planning.
- Support infrastructure funding strategies and pursue external funding opportunities such as grants and partnerships.

- Lead the preparation and administration of the annual operating and capital budgets, including monitoring financial performance and providing variance analysis.
- Manage reserve and reserve fund strategies to ensure long-term fiscal health, along with cash flow, investments, and debt financing.
- Provide leadership, mentorship, and performance management to the Finance Department team, fostering a culture of collaboration, continuous improvement, and professional development.
- Represent the Finance Department at Council and committee meetings, and actively participate in the senior management team, contributing to corporate decision-making.
- Ensure staff are knowledgeable of and in compliance with the Occupational Health and Safety Act, WHMIS, and all applicable legislation, regulations, policies, and safe work practices.
- Uphold the Town’s core values of integrity, accountability, empowerment, purposefulness, and service excellence while acting as an Ambassador in the community.
- Perform other duties as assigned in support of the overall goals and objectives of the Town.

The Director of Finance/Treasurer will oversee the Finance and Procurement Teams, which includes 9 full-time team members in both non-union (management) and one collective bargaining unit (IBEW).

Additional training or certifications in municipal finance, asset management, or public administration would be considered assets.
- **Experience:** Minimum of seven (7) to ten (10) years of progressive finance experience, including supervisory responsibilities in a municipal environment or an environment that works closely with municipalities. Demonstrated expertise in accounting, budgeting, taxation, procurement, and financial reporting. Experience working with Council, senior leadership, and external auditors is essential.
- **Technical Knowledge:** In-depth knowledge of the *Municipal Act, 2001*, Public Sector Accounting Standards (PSAS), municipal budgeting practices, and financial reporting requirements. Strong proficiency in financial software and Microsoft Office Suite. Familiarity with procurement processes, investment management, debt financing, and asset management planning.
- **Strong Communication Skills + Political Acuity:** Skilled at preparing and delivering clear, concise financial reports and strategic recommendations to Council, Committees, and senior staff. Strong written and verbal communication skills, with the ability to explain complex financial information to diverse audiences.
