

Job Responsibilities

The Senior Planner is responsible to provide professional planning advice to Council, members of the public, property owners, property developers and staff with respect to land use and zoning within the Municipality of Port Hope.

The role involves actively participating in the review, research, and policy planning of the Municipal Official Plan and zoning by-laws, ensuring compliance with evolving Provincial Policies and legislation. Responsibilities include managing planning and development applications while collaborating with internal and external stakeholders to negotiate land use. The position also entails representing the Planning division, providing recommendations to Council, and facilitating public consultation on planning matters. Additionally, the role extends to preparing and approving planning recommendations, by-laws, and development agreements, overseeing planning studies and projects, and participating in Ontario Land Tribunal hearings as an expert witness.

Furthermore, the position entails leadership responsibilities, including providing guidance and mentorship to Planning staff, fulfilling the Manager of Planning's duties in their absence, and ensuring courteous and informative interactions with the public. Senior Planner is expected to uphold high ethical standards, recognizing the impact of personal actions on the Municipality's public perception.

Key Responsibilities

Strategic Planning and Policy Development:

- Assist in the review, research, policy planning and update of the Municipal Official plan and zoning by-law for the Municipality; monitor and advise Management on compliance with changing Provincial Policies and legislation (e.g. Growth Plan, Oak Ridges Moraine Conservation Plan, Green Energy Act, County official plan and others).
- Undertake planning studies and projects within specified timelines and an approved budget. Coordinate the activities of external consultants, including but not limited to the hiring of consultants, developing and issuing RFQ's, RFPs, pre-qualifications, participation in the evaluation/selection process, and contract award including oversight of budgets and invoicing.

Community Partnership in Planning Development Processes:

 Represent the Planning division and provide recommendations and professional planning opinion to Council, the public, special purpose bodies, committees, government agencies, stakeholders, and interest groups by communicating information, corporate objectives, recommending courses of action and facilitating solutions

- Attend Council meetings, Committee of the Whole meetings, and other Committees of Council as required. Facilitate and lead public consultation and community outreach meetings on planning matters.
- Seek funding opportunities from government grants, private donors, and other sources to support program expansion and innovation.

Legal Knowledge in Municipality Zoning By-Laws:

- Prepare and approve planning recommendations for development applications, including Committee of Adjustment consent applications, and Minor Variance applications.
- Prepare and approve by-laws and development agreements, including building permit application review for compliance with zoning by-law, site plans, and subdivision agreements staying in consultation with several municipal departments, agencies and legal counsel.
- Prepare, review and comment on Motions, Affidavit, Orders, Outline of Evidence, Witness Statements, in preparation for Ontario Land Tribunal ("OLT") hearings.

Stakeholder & Community Engagement and Delivery of Service:

- Manage planning and development applications, including Official Plan amendments, zoning by-law amendments, consent and minor variances, plans of subdivision, and site plan proposals in compliance with applicable Municipal and Provincial legislation.
- Attend OLT hearings as an expert witness pertaining to land use and other planning matters including appeals and coordination of same in cooperation with the Municipal Solicitor and staff on behalf of the Municipality, providing evidence and professional opinion at OLT hearings.
- Demonstrate commitment to delivery of services and interact with the public in a courteous, informative, appropriate and prompt manner at all times and in all circumstances
- Provide information regarding services as an expert, and support Municipal policy, procedures and by-laws.

- Membership in the Canadian Association of Heritage Professionals (CAHP) would be an asset.

- Experience representing the Planning division and providing recommendations and professional planning opinion to stakeholders by communicating information clearly, recommending courses of action, and facilitating solution.
- Expertise in managing the planning and development of applications such as the Municipal's Official Plan and Zoning by-law in compliance with Provincial Policies, and ability to provide recommendations to Council and engage in public consultation.

Communication, Interpersonal Skills and Leadership:

• Demonstrate a commitment to delivery of services and interact with the public in a courteous, informative, appropriate and prompt manner at all times and in all circumstances; provide information regarding services in area of expertise and support Municipal policy, procedures and by-laws.
